CONVENTION SESSION 1

Call to Order

The seventy-ninth convention of the Minnesota South District of The Lutheran Church—Missouri Synod was called to order at 1:25 p.m. by Rev. Dr. Lucas Woodford, President, in the name of the Father and of the Son and of the Holy Spirit. He briefly explained the convention theme and logo.

Opening Devotion: Bible Study 1 – Everything IN THE NAME OF JESUS – Colossians 3:17. Rev. Stefan Wismar, Executive Assistant to the President

The assembly began by singing "How Sweet the Name of Jesus Sounds" (LSB 524). Rev. Stefan Wismar led a Bible study focusing on the Convention's theme verse, Colossians 3:17, specifically "Everything in the Name of Jesus." The goal of his Bible study was reminding every participant to not only believe *Jesus* is the name above all names, but also to faithfully live under that name's power. Rev. Wismar concluded his Bible study with prayer. The assembly prayed the Lord's Prayer.

Welcome and Report: Concordia University, St. Paul (Rev. Dr. Brian Friedrich, President)

President Woodford introduced Rev. Dr. Brian Friedrich, who began serving as the 10th President of Concordia University, St. Paul, on January 1, 2020. President Friedrich welcomed those attending the convention and reported on the status of the University.

Constitution & Membership Committee (Rev. Matthew Moss, Chair)

Rev. Moss reported that from September 2012 through their most recent meeting on April 9, 2022, the Committee reviewed 75 constitutions. Twenty-two constitutions were recommended for approval to the Board of Directors. The 75 total submissions represent 33 congregations. In addition, the Committee

returned 53 constitutions to congregations with recommended changes. Finally, 12 congregations have received their materials back with our comments, but have not yet submitted an approved Constitution & Bylaws. Rev. Moss strongly encouraged congregations planning on revising their constitution and bylaws to utilize the helps and checklist available on the district's website and also that a series of tutorial videos on the process was in the works.

Rev. Dr. Lucas Woodford called Convention Session 2 to order at 8:10 a.m.

Devotion and Bible Study 3 – PEACE in the Name of Jesus – Colossians 3:15. Rev. Dr. Samuel Deressa, Assistant Professor Religion and Theology at Concordia University, St. Paul

The assembly sang "When Peace, Like a River" (LSB 763). The goal of Dr. Deressa's presentation is that participants understand peace in relation to God, ourselves, each other, and the whole creation. Dr. Deressa noted that the passive verb "you have been raised" (Col. 3:1) points to God's action in our lives. Setting our hearts/minds on things above is not self-contrived, but enabled and brought only by God's grace. Peace is far more than the absence of war. Peace results from God reconciling sinful humanity to Himself through Christ. God is the giver of peace "in Christ" through baptism and faith. Finally, only those who are "in Christ" are one in Christ and with each other.

District President's Triennium Address

Rev. Dr. Lucas Woodford addressed the assembly stating that we do everything in the powerful name of Jesus across our District. He noted how he is intentionally trying to bridge the gap between confessional and missional mindsets. It's time to be faithful and bold sharing the name and message of Christ as we face the challenges and opportunities before us.

Resolutions A-B-C-D

President Woodford mentioned Omnibus resolutions are overtures that have been declined by respective floor committees. The motion was made to approve Omnibus Resolution B, which declined Overture 5-02: *To Reduce Redundancy*. This overture is already addressed by 2018 District Res. 4-03a. The resolution was adopted. Yes: 270 / 88.1% No: 32 / 11.9%

Now we will consider Omnibus Resolution C which includes Overture 2-02 and Overture 2-03. First, Overture 2-02: To Encourage Proper Pastoral Oversight in Administration of the Lord's Supper through Visitation of Ecclesiastical Supervisors. The reason given for declining this overture is this matter has already addressed by Bylaws 4.4.4 and 4.4.5 in the 2019 LCMS Handbook. Second, Overture 2-03 To Develop Further Depth and Theological Oversight in the Training of Pastors from Immigrant Communities. The reasons given for declining this overture are:

- 1. The seminaries have exclusive control of the certification process of all seminary program students and candidates.
- 2. The district does not have the authority to control or change this process. The assembly may now consider whether it concurs with this action of declining Overtures 2-02, and 2-03 for these reasons. The resolution was adopted.

WHEREAS, the "granting of Recognized Service Organization status by the Synod signifies that a service organization, while independent of the Synod, fosters the mission and ministry of the church, engages in program activity that is in harmony with the programs of the boards of Synod, and respects and does not act contrary to the doctrine and practice of the Synod" (LCMS Bylaw 6.2.1); and

WHEREAS, the "mission and ministry of the church" and the "doctrine and practice of the Synod" includes the faithful reception of our Lord's gifts at the Divine Service, which for most congregations is only offered on the Lord's Day (Sunday); therefore be it

Resolved, that the Minnesota South District in convention encourage Camp Omega to provide programming which guards Sunday morning for attendance at the Divine Service for all those associated with the camp; and be it finally

To each is given the manifestation of the Spirit for the common good" (1 Corinthians 12:4-7); and
- WHEREAS, "Through the Word and Sacraments, as through instruments, the Holy Spirit is given. He works faith, when and where it pleases God, in those who hear the good news" (Augsburg Confession V:1-2); and
- WHEREAS, the congregations of The Lutheran Church—Missouri Synod in the Minnesota South District include people from every continent in the world whom the Holy Spirit has called by the Gospel to live as God's people in this place; and

- WHEREAS, the Holy Spirit by the same Gospel gathers, enlightens, sanctifies, and keeps us with Jesus Christ in the one true faith (Small Catechism, Third Article of the Apostles' Creed); and
- WHEREAS, the congregations and workers of our District have been placed in a wide variety of contexts including rural, small town, suburban, and urban areas; areas of population growth or decline; situations that require the use of languages other than English or the interaction of various ethnic groups; areas of poverty or wealth; and so forth; and
- WHEREAS, our common mission and ministry includes both the gathering of God's people around the Gospel in Word and Sacraments and the intentional searching for the lost (Matthew 28:18-21, Mark 16:15-16, Acts 2:41-42, Hebrews 10:23-25); and
- WHEREAS, the articles of incorporation of the Minnesota South District state that purpose of the District is to facilitate the establishment of new ministries and congregations within the territorial limits of the District (MNS Article of Incorporation, Article 1, Sec. 2, d); and
- WHEREAS, all regions of the District include a significant number of baptized Christians who neglect public worship or fail to seek out the lost around them; therefore, be it
- Resolved, That the Minnesota South District in convention affirm that our common mission and ministry includes both the regular gathering of God's people around the Word and Sacraments and the intentional evangelizing and discipling of our neighbors for whom Christ also died; and be it finally
- Resolved, That in the coming triennium, the leadership of our District work especially to encourage and foster partnerships across our District, that we may be strengthened in our unity of faith through the faithful use of God's Word and Sacraments, rejoice in our common mission and ministry, and support one another as we learn of the unique challenges and opportunities that each congregation, school, and worker has been given in the place where God has put us.

- WHEREAS, the Reverend Doctor Laokouxang (Kou) Seying was the first Hmong pastor ordained in The Lutheran Church—Missouri Synod; and
- WHEREAS, the Reverend Doctor Laokouxang (Kou) Seying devoted his life and ministry to expanding crosscultural and multiethnic ministry in the congregations, universities, seminaries, and global missions of our Synod; and
- WHEREAS, the Reverend Doctor Laokouxang (Kou) Seying intentionally worked to raise up a new generation of church workers from the Hmong and Laotian community; therefore, be it
- Resolved, That the Minnesota South District give thanks to the Lord of the Church for the life and ministry of the Reverend Doctor Laokouxang (Kou) Seying and for his lasting contributions toward cross-

cultural and multiethnic ministry and his living legacy of multiethnic pastors and other church workers in our church body; and be it further

Resolved, That the Minnesota South District in convention hereby memorializes the Synod to adopt this resolution at its 2023 convention; and be it finally

Resolved, That the Minnesota South District in convention thank the Lord of the Church for the life and ministry of the Reverend Doctor Laokouxang (Kou) Seying by standing and singing together the Common Doxology in English and Hmong.

Resolution 1-03

To Evangelize Our Unchurched / Unclaimed Students and Their Parents

WHEREAS, Jesus says, "Let the little children come to me and do not hinder them, for to such belongs the kingdom of heaven" (Matthew 19:14); and

WHEREAS, many of the congregations of the Minnesota South District have a long history of providing Christcentered education for the children in their communities; and

WHEREAS, there are currently 43 Early Childhood programs, 35 Elementary (K-8) schools, and 4 High Schools in the Minnesota South District; and

WHEREAS, enrollment in the past year has increased 15% in these Early Childhood programs, and 13% in these Elementary (K-8) schools, and 15% in these High Schools; and

WHEREAS, 32% of the students in these Early Childhood programs, and 13% of the students in these Elementary (K-8) schools, and 8% of the students in these High Schools are unchurched/unclaimed for any religion, whatsoever; and

WHEREAS, our Minnesota South District pastors, educators, leaders, and laypeople are 35 all called to be intentionally engaged in the mission of God; therefore, be it

Resolved, That the Minnesota South District urge its pastors, educators, leaders, and lay people to view this increase in unchurched/unclaimed students as a ripe mission field; and be it further

Resolved, That the Minnesota South District urge its pastors, educators, leaders, and lay people to view the families of these unchurched/unclaimed students as a ripe mission field; and be it finally

Resolved, That this Convention direct the District's Schools and Commissioned Workers Committee, it's Mission Formation Committee, and its Missions Committee to increase awareness of services and resources available to congregations, institutions, schools, and professional church workers so that they are thinking, planning, and acting in ways that facilitate the intentional evangelizing of the unchurched/unclaimed students and their families in our midst.

Resolution 1-04

To Encourage Revitalization of Existing Congregations of the Minnesota South District

- WHEREAS, our Lord Jesus Christ has established the ministry of the Word and Sacraments as the means for obtaining saving faith in the Holy Gospel (Augsburg Confession V:1-2); and
- WHEREAS, the Church has been commissioned by our Lord Jesus Christ to preach that same Gospel and to baptize all nations (Matthew 28:19), and
- WHEREAS, the number one mission priority of The Lutheran Church—Missouri Synod is "Making Disciples for Life" includes sustaining and revitalizing existing Lutheran churches (www.lcms.org/about/seven-mission-priorities); and
- WHEREAS, the Minnesota South District of The Lutheran Church—Missouri Synod is "Synod in this place"; and
- WHEREAS, our Synod has made a concerted effort through the Office of National Mission particularly through, though not limited to, its program "Re:Vitality";
- WHEREAS, many existing congregations in the Minnesota South District long for revitalization and District through its staff stand ready to assist congregations in the revitalization process; therefore, be it
- Resolved, That congregations of the Minnesota South District be encouraged to make greater use of the revitalization resources available to them from their District and Synod; and be it further
- Resolved, That the Minnesota South District and its staff continue their efforts to assist existing congregations in their efforts to further develop outreach and mission throughout the coming triennium and beyond; and be it further
- Resolved, That the Minnesota South District and its staff inform local congregations and circuits of the mission and revitalization work of the District both locally and regionally; and be it finally
- Resolved, That the congregations of the Minnesota South District be encouraged both to support and utilize the Mission Formation Legacy Fund of the District in their revitalization effort.

- WHEREAS, Jesus said, "The Harvest is plentiful, but the laborers are few; therefore, pray earnestly to the Lord of the harvest to send out laborers into his harvest" (Matthew 9:37-38); and
- WHEREAS, God is bringing thousands of new immigrants to our communities and thereby providing our congregations with new and vast harvest fields; and
- WHEREAS, our Minnesota South District pastors and congregations are identifying new potential pastoral leaders in and among these immigrant communities;

WHEREAS, our synodical seminaries have established a distance theological education through the Specific Ministry Pastor (SMP), Ethnic Immigrant Institute of Theology (EIIT), Cross-Cultural Ministry Center (CMC) and Center for Hispanic Studies (CHS) programs; and

WHEREAS, an unintended consequence of synod promoting residential seminary education as the preferred option for the preparation of men for pastoral ministry (2019 LCMS Resolution 6-02) is that non-residential, immigrant students do not receive the same tuition assistance from the seminary to cover the costs of their academic programs as compared with residential students; therefore, be it

Resolved, That the District in convention encourage the seminaries to award the same tuition assistance as residential students to their nonresidential students, and be it finally

Resolved, That the District hereby memorializes The Lutheran Church-Missouri Synod to adopt this, or similar resolutions, at its next convention.

Resolution 2-02A

To Reject the Practice of Internet Communion

WHEREAS, the Sacrament of the Altar is the true body and blood of our Lord Jesus Christ, under the bread and wine, instituted by Christ Himself for us Christians to eat and to drink (Small Catechism VI); and

WHEREAS, the Holy Evangelists Matthew, Mark, Luke, and St. Paul write: Our Lord Jesus Christ, on the night when He was betrayed, took bread, and when He had given thanks, He broke it and gave it to His disciples and said: "Take eat; this is My body, which is given for you. This do in remembrance of Me." In the same way also He took the cup after supper, and when He had given thanks, He gave it to them, saying: "Drink of it, all of you; this cup is the new testament in My blood, which is shed for you for the forgiveness of sins. This do, as often as you drink it, in remembrance of Me" (Matthew 26:26-28; Mark 14:22-24; Luke 22:19-20; 1 Corinthians 11:23-25); and

WHEREAS, during the COVID-19 lockdowns beginning in March 2020, some LCMS pastors in a desire to faithfully commune their members began a practice which has come to be known as "Internet Communion"; and

WHEREAS, the practice of "Internet Communion" introduces a spatial gap that severs the consecration of the elements from the reception of the elements and therefore introduces doubt where there should be clarity and confidence in the sacrament (Luke 22:19; 1 Corinthians 11:26; AC XIII); and

WHEREAS, the Lutheran Confessions teach, on the basis of God's Word, that valid communion involves the proper consecration, distribution, and reception of the elements, and that nothing has the character of a Sacrament apart from its appointed use, such "use" being defined by the Formula of Concord as "the entire external and visible action of the Supper as ordained by Christ" (FC SD VII:85); and

WHEREAS, the Council of Presidents of the Synod in its unanimously adopted statement of September 11, 2021, "To Encourage Advocating In-Person Communion," rightly affirmed that "No theological justification for the novel practice of online or virtual communion has existed within the Synod or

in the Lutheran tradition nor has been advanced in the circles advocating for it on the basis of the principally relevant texts (sedes doctrinae) of Holy Scripture or of the Lutheran Confessions"; and

WHEREAS, the Commission on Theology and Church Relations has properly confessed, on the basis of God's Word, the true doctrine and practice of the Lord's Supper and has rejected the practice of "Internet Communion" in the documents titled "Communion and Covid-19" and "One little Word Can Fell Him: Addendum to Communion and Covid-19"; therefore, be it

Resolved, That the MN South District encourage all pastors and congregations to reject the practice of "Internet Communion"; and be it further

Resolved, That we commend the desires of faithful pastors to care for their flocks in a time of pandemic, granting charity and latitude to our brothers in the office due to the emergency nature of the situation confronting us all; and be it further

Resolved, That the MN South District memorialize the 2023 LCMS Convention to further study the practice of "Internet Communion" on the basis of God's Word and the Lutheran Confessions; and be it finally

Resolved, That the MN South District encourage the faithful practice of in-person communion services in our public worship services and in such cases of pastoral care where communion is desired.

Resolution 3-04

To Speak the Gospel Clearly in the Cultural Context of Critical Race Theory (CRT)

WHEREAS, God has created all people and they are blood-related going back to our mutual fathers, Adam and Noah, and therefore there is only one race, the human race, and all are subject to the stain of original sin, but even now also have been equally redeemed by the blood of Christ in order to be reconciled to God and each other; (Genesis 1:26-28, Genesis 10, Romans 5:12-21, I Corinthians 15: 20 -23, Acts 17:26); and

WHEREAS, CRT asserts that racism is present in all aspects of life, in every relationship and every interaction; and that its advocates urge their followers to look for, and expect to find, racism everywhere, it is clear that the goal and effect of CRT is to cause deep and irreconcilable divisions within society; and

WHEREAS, society has, in recent years, been deeply convulsed by the efforts of some to eliminate historic racism through the introduction of a new, more toxic form of racism which adds elements of Marxist and post-modern thought to the historic form; and

WHEREAS, the academic discipline of critical theory and its progeny, such as CRT, is inconsistent with the Christian worldview and also irreconcilable with Holy Scripture; and

WHEREAS, critical theory, when applied to theology, frequently denies the sufficiency of Christ's death to forgive all people by claiming that forgiveness is impossible for certain people based on their race; and by heretically confusing the righteousness we have before God for Jesus' sake with the civil righteousness of the "social gospel"; and

- WHEREAS, the "solutions" to racial inequities proffered by CRT do not come from Christ but rather from a theory of grievance and retribution (and can produce only more of the same); and
- WHEREAS, God's Word says, "If you really fulfill the royal law according to the Scripture, 'You shall love your neighbor as yourself,' you are doing well. But, if you show partiality, you are committing sin and are convicted by the law as transgressors" (James 2:8-9); and
- WHEREAS, we still recognize that racism, misunderstanding, and strife are and will continue to be present in the world and in the Church; and
- WHEREAS, the LCMS in convention has passed resolutions repudiating all racism, for example, 1992 Res.3-03; and 2019 Res. 11-04A; therefore, be it
- Resolved, That the Minnesota South District in convention reaffirm the Synod's repudiation of racism in all its forms; and be it further
- Resolved, That the Minnesota South District call upon her members to love their neighbors as themselves, and seek to live in peace and harmony with all people by proclaiming that Jesus is Lord, and by bringing forth the fruits of the faith in serving the neighbor; and be it further
- Resolved, That the Minnesota South District reject the worldview of CRT, because it is contrary to Scripture and counterproductive to true racial conversation and reconciliation, since it pursues equality of outcome ("equity") between ethnic or cultural groups, while cynically insisting that we treat individuals unequally based on skin color, ethnicity, ancestry, or nationality; and be it further
- Resolved, That the Minnesota South District reject any doctrine, such as that proposed by CRT, that teaches that an individual or organization is inherently racist, or oppressive, whether consciously or unconsciously, solely on account of skin color, ethnicity, ancestry, nationality, or history; and be it further
- Resolved, That the Minnesota South District reject the teaching of all organizations, movements, and petitions which attempt to advance the language and/or concepts of Critical Theory including CRT; and be it finally
- Resolved, That the Minnesota South District in convention memorialize the LCMS to also reject the worldview, language and concepts of Critical Race Theory at its 2023 convention.

Resolution 3-02

To Remind All that God Has Appointed Parents to be the Primary Authority in the Life of Their Children

- WHEREAS, in the Scriptures, we read: "Children, obey your parents, for this is right"; and, "Honor your father and your mother which is the first commandment with promise that it may go well with you and you may enjoy a long life on the earth" (Eph. 6:1-3); and
- WHEREAS, Luther in his explanation to the 4th Commandment, makes it clear that "all who are called masters stand in the place of parents and must derive from them their power and authority" (Book of Concord, Kolb and Wengert, p. 406); and

- WHEREAS, Luther further declares that God has given fatherhood and motherhood a special position of honor, higher than that of any other walk of life"; and, that God "places them near to Himself" (p. 409); and
- WHEREAS, it has become increasingly common in modern society and in matters of education, in particular, to treat the office of parent as subsidiary and inferior to that of the State and its agents; and
- WHEREAS, parents are increasingly seen by progressive educational authorities as bigoted and ignorant and thus "obstacles" to the proper instruction of children; and
- WHEREAS, it is increasingly clear that educational authorities behaved in ways which lead children to question the authority and competence of their parents and to reject other authority figures including grandparents and religious leaders in their life; and,
- WHEREAS, educational authorities are even regularly found to have formal or informal policies which forbid teachers and staff from informing parents about issues of sexuality and transgenderism that surface in the school setting; and
- WHEREAS, school systems are increasingly unwilling to be fully transparent with Parents regarding the content of materials used to educate their children; therefore, be it
- Resolved, That the Minnesota South District of the LCMS, in convention, clearly and unequivocally reassert the Scriptural truth that God has given to parents both the primary responsibility and the primary authority in the lives of their children; and that all other authorities in the lives of children derive their authority from parents; and be it further
- Resolved, That pastors and teachers of the Church be encouraged to regularly focus attention on the application of the 4th Commandment in our modern American context and, in so doing, to lift up and expound on the Godly and high office of parent; and be it further
- Resolved, That the Church rejects the claim of many schools that parents may be prevented from having full access to their children's records and reasonable control over their child's educational experience; and be it further
- Resolved, That the Church support parental empowerment mechanisms such as Education Savings Accounts, which remove inappropriate State bias in parental decision-making in matters of education, by allowing State-collected education dollars to follow the child to any school of the parents' choosing, including religious schools; and be it finally
- Resolved, That the Minnesota South District, in convention, memorialize the LCMS to use its resources and influence to elevate the place of parents in our Church and our society.

Resolution 3-03

To Encourage Members of LCMS Congregations to Seek Political Office

WHEREAS, Jesus has called us not only to love God but also "our neighbor as ourselves" (Lk 10:27); and

- WHEREAS, God's people have always been called to "seek the peace and prosperity of the city" in which they reside, even if that residence is "in exile in a foreign land" (Jer. 29:7); and
- WHEREAS, Luther, in his explanation of the Two Kingdoms doctrine, clearly calls on Christians to make themselves available to hold public office, and, in fact, declares Christians to be more fit to hold such office than "any other men on earth" (AE 45:100); and
- WHEREAS, it is clear that, when compared to Biblical standards of order, our nation and its public life are more disordered and chaotic now than at any other time in living memory, and therefore, is in great need of mature and prudent leadership informed by the Word of God, more than ever before; therefore, be it
- Resolved, That the Minnesota South District of the LCMS, in convention, renew and amplify our call for members of our LCMS congregations to actively consider making themselves available for public office at whatever level of government seems most fitting; and be it further
- Resolved, That we highly commend those members who are currently serving in such elected office, assuring them of our deep appreciation for their service as well as pledging them our continuing support as they carry out their high calling and praying that God would sustain them in what is often a lonely and thankless job; and be it further
- Resolved, That we encourage all of our members to exercise their citizenship through active participation in the political process, not seeking to serve personal interests but always seeking to serve the common good in the name of Jesus and according to Holy Scripture; and be it finally
- Resolved, That we encourage our Lutheran schools as well as the public schools in our communities, to place a renewed emphasis on the teaching of civics and our form of government (democratic republic), that our youth might grow in their love for our nation and its founding ideals, and that they, too, might be inspired to consider lives of public service, fully informed by their Christian faith.

Resolution 4-01

To Challenge Every Congregation to Seek Collaborations toward Ministry Stabilization and Growth.

- WHEREAS, St. Paul states, "I can do all things through [Christ] who strengthens me," and yet goes on to say of the Christians in Philippi, "Yet it was kind of you to share in my troubles" (Phil. 4:13-14); and
- WHEREAS, our Lutheran Church Missouri Synod identifies in the preamble of its constitution, a reason for the forming of a synodical union is "our Lord's will that the diversities of gifts should be for the common profit (I Cor. 12:4-31)"; and
- WHEREAS, the 2018 MNS District passed Resolution 3-02, To Expand Mission Awareness and Activity within the Minnesota South (MNS) District which in part resolved, "That congregations be encouraged to form partnerships with others in their circuit and region to intentionally engage their communities and do mission outreach and service;" and

WHEREAS, in the course of this past triennium, twelve congregations of the MNS District chose to close when unique collaborations with other congregations might have allowed ministry to continue in those locations; therefore, be it

Resolved, That MNS District congregations within their various circuits make every attempt to share in each other's troubles, especially by developing creative collaborations with sister congregations that encourage Word and Sacrament ministry to continue in our neighborhoods and communities; and be it further

Resolved, That MNS District congregations that are in decline and are considering closing be encouraged to reach out to sister congregations and, with a willing spirit, for the sake of the Kingdom, and to the glory of God, explore with them opportunities for walking together and the changes this may bring (e.g., worship service times, structure, sharing resources and staff, etc.); and be it finally

Resolved, That the congregations of the MNS District join together in prayer, being led by the convention chaplain, to God for all of the gifts He has provided for the well-being of His people, including the blessings of faithful partners within our synodical union.

Resolution 4-02

To Exhort Congregations to Actively Encourage Current and Future Lutheran School Teachers.

- WHEREAS, the declaration of Jesus, "The harvest is plentiful, but the laborers are few. Therefore, pray earnestly to the Lord of the harvest to send out laborers into his harvest" (Luke 10:2), is as true today as when it was spoken 2,000 years ago; and
- WHEREAS, only 38 percent of teachers serving in MNS District Lutheran schools are on the active Commissioned Minister roster of The Lutheran Church—Missouri Synod (2022 District Convention Workbook, page 66); and
- WHEREAS, Res. 8-01A of the 2016 Synod convention specifically identified that a characteristic of a Lutheran school with a strong Lutheran ethos has "LCMS-trained Lutheran teachers... who know and are committed to the truths of the Scriptures as confessed in our Lutheran Confessions"; and
- WHEREAS, the fulfillment rate of requests for first-year Synod-trained candidates to LCMS calling entities has declined from 63 percent in 2010 to 30 percent in 2018 because of the lack of available Synod-trained candidates (Concordia University System Board of University Education statistics); and
- WHEREAS, the Concordia University System (CUS) is anticipated to graduate only 88 total graduates available for placement in 2022 (CUS placement directors' report, Dec 2021); and
- WHEREAS, one of the top factors tied to the likelihood of a young person considering teaching is the direct encouragement of their teachers and school administrators ("What's Happening in our Schools?" Concordia Plan Services research); and
- WHEREAS, the Synod developed Set Apart to Serve, a comprehensive, multi-year church worker recruitment initiative, acting on the 2019 Synod Resolution 6-01; and

WHEREAS, 55% of public school educators are thinking of leaving the profession earlier than planned or retiring early due to the stress of the pandemic, according to a 2022 National Educators Association (NEA) survey; therefore, be it

Resolved, That the congregations of the MNS District and their pastors and teachers, being led by the Holy Spirit, actively identify and encourage future Lutheran school teachers; using the Set Apart to Serve initiative of the Synod; and be it further

Resolved, That the congregations of the MNS District and their pastors actively seek faithful members employed as teachers outside of Lutheran education who may be ready to answer the call of ministry in Lutheran schools; and be it further

Resolved, That the District and its congregations work to increase the Lutheran identity of our schools by providing scholarships to enable current non-rostered teachers to complete teacher colloquy; and be it finally

Resolved, That the District and its congregations strongly consider providing financial support for future Synod-trained Lutheran teachers.

Resolution 4-03

To Encourage and Support Evangelism through Lutheran Schools

WHEREAS, the establishment of Lutheran schools in America has been a priority of faithful Lutherans even before they joined to form the LCMS; and

WHEREAS, Minnesota South (MNS) District elementary schools have increased in enrollment by 23% since 2018 and 13% in the last year and high schools have increased in enrollment by 11% since 2018 and 15% in the last year (2018–2021 Synod School Statistical Report); and

WHEREAS, one-fifth of all students enrolled in MNS District schools come from families that disclose they are unchurched (one-third in the early childhood schools) (2018–2021 Synod School Statistical Report); and

WHEREAS, 246 students were baptized into the faith through our schools (2018–2021 Synod School Statistical Report); and

WHEREAS, the Office of National Mission (ONM) has identified planting schools as a priority for this triennium (2019 Resolution 4-03); and

WHEREAS, in 2017 the LCMS found that a congregation that operated or was associated with a Lutheran school had higher retention rates (Retention of Lutheran Millennials: LCMS Study of Young Adults, 2017); therefore, be it

Resolved, That the congregations of the MNS District support and uplift our Lutheran schools in prayer and encourage them to continue to be faithful to God's Word and strive for excellence in catechizing and educating the students in their care; and be it further

Resolved, That best practices and resources on evangelism and outreach through Lutheran schools be collected and shared by MNS District staff to equip congregation leaders; and be it further

CHAPTER 7: AMENDMENTS TO BYLAWS

7.3 District Compliance to Synod Constitution and Bylaw Changes

When necessitated by amendments to the Synod Constitution or Bylaws or otherwise expressly directed by a resolution of the Synod in convention, amendments may be made by a two-thirds majority of the District board of directors. Such amendments shall be drafted by the District secretary and shall be reviewed and approved in advance by the LCMS Commission on Constitutional Matters.

Resolution 5-02

To Clarify Sharing Gifts on a 50% / 50% Basis with the Synod

WHEREAS, God has always provided for the Minnesota South District of The Lutheran Church—Missouri Synod ("District"); and

WHEREAS, the 2000 District Convention (Resolution 3-01) directed the District to split all offering receipts 50%/50% with The Lutheran Church—Missouri Synod ("Synod"); and

WHEREAS, the resolutions of the convention and practical application of those resolutions would benefit from clarification; and

WHEREAS, donors interested in the work of the District are not always aware of the 50%/50% split and have expressed an interest in keeping their gifts within the District; and

WHEREAS, the District would like to provide transparency to donors regarding the allocation of their gifts; therefore, be it

Resolved, That any undesignated gifts that come to the District be split 50%/50% with the Synod; and be it further

Resolved, That any donor-designated gift to Synod or an existing fund of the District be retained by the District in accordance with the donor's designation and such gift be passed through or added to the designated fund accordingly; and be it further

Resolved, That any donor-designated gift for a purpose not within an existing fund be held aside until its acceptance and fund approval by the District Board of Directors; and be it finally

Resolved, That any profits from investments of District funds may be retained 100% by the District.

Resolution 5-03A

To Provide Financial Support to Camp Omega

WHEREAS, Camp Omega, Inc. ("Camp Omega") is a Recognized Service Organization of The Lutheran Church Missouri Synod ("LCMS") in the Minnesota South District ("District"); and

WHEREAS, the District has financially supported the ministry of Camp Omega for more than twenty years; and

WHEREAS, the District gifted the camp property to Camp Omega in late 2020 thereby shifting responsibility for insurance, property taxes, and other expenses to Camp Omega; and

WHEREAS, Camp Omega faithfully serves the children, youth, and adults of our District congregations and many others; therefore, be it

Resolved, that the District provide annual financial support in the amount of \$20,000 for the 2022 Triennium to Camp Omega; and be it further;

Resolved, that Camp Omega provide an annual report to the Board of Directors of the District; and be it finally

Resolved, that the Board of Directors can deny annual financial support if Camp Omega loses its standing as a Recognized Service Organization of the LCMS or if the Board of Directors deems Camp Omega is not operating in accordance with the accepted doctrines and practices of the LCMS.

Resolution 5-04

To Be Gospel Centered in Corporate and Spiritual Missions

WHEREAS, the ministry of the Gospel is to be foremost and central in our life together in the District; and

WHEREAS The Articles of Incorporation and By-Laws should reflect this Gospel centrality; therefore, be it

Resolved, That The Articles of Incorporation, Article I, Section 2, a) be amended, as follows, The general purposes of this Corporation shall be: a) To provide services and assistance to those congregations of THE LUTHERAN CHURCH-MISSOURI SYNOD, (herein from time to time "the LCMS or "the Synod), in the ministry of the Gospel, located within the territorial limits of this Corporation in furtherance of their respective corporate and spiritual missions, including, but not limited to, providing assistance in the process of calling those church workers ordained or otherwise in or by the LCMS.

Each one must give as he has decided in his heart, not reluctantly or under compulsion, for God loves a cheerful giver. And God is able to make all grace abound to you, so that having all sufficiency in all things at all times, you may abound in every good work. As it is written, 'He has distributed freely, he has given to the poor; his righteousness endures forever.'" [ESV] therefore, be it

Resolved, That the Minnesota South District encourages Biblical stewardship practices in our congregations, and be it further

Resolved, That pastors, church workers, and congregations be encouraged to use synodical resources concerning stewardship, and be it finally

Resolved, That the Minnesota South District in convention thank God for cheerful stewardship by rising to sing the Doxology.

Resolved, That the Minnesota South District set up a webinar to educate congregational leadership on the mental health care resources available for their workers; and be it further

Resolved, That this webinar include representatives from a multitude of caregivers; and be it finally

Resolved, That this webinar be recorded and be made available to church workers and congregational leadership at a convenient time. Leadership to include parish council, elders, parish nurse, and other leaders who have a heart for the workers.

("Lord Jesus, You are the heavenly Physician who is able to give health to the body, wholesomeness to the mind,

and peace to the soul. Conduct Your ministry of mercy in all the hospitals and nursing homes of our communities and grant Your healing to the distressed. Give patience, wisdom, and perseverance to all of our frontline workers as they minister to those in need. Grant each of these workers a special measure of Your love and understanding toward those that are frightened and in pain. Lord Jesus Christ, we call on you to be present according to your Word in every place to hold up those who work to bring mercy and healing care at great risk to themselves. When they are weary and tired of serving, when the burden has become too heavy may they accept Your invitation to come to you, whose yoke is easy and whose burden is light, and find rest for their souls.
