First Session

Call to Order

The Reverend Dr. Lane Seitz, President of the Minnesota South District, called the convention to order in the name of the Father and of the Son and of the Holy Spirit.

Opening Devotion

43

President Seitz introduced the Reverend Victor Meyr, conference co-chaplain. President Seitz explained that the other co-chaplain, the Reverend Fred Miller, has

1 been in ill-health the past few months but that he would join the convention for the
2 Friday afternoon devotion.

3
4 Chaplain Meyr began by reading Genesis 1:20-21. He referred to a *National*
5 *Geographic* article in which harbor seals were caught in nets and people were
6 rescuing them. He mentioned that we sinners are like the harbor seals caught in the
7 net and needing someone to come and rescue us. Chaplain Meyr introduced Dr.
8 Jeffery Burkart, who led the delegates in singing the song "Our Mission is Fishin'"
9 which he was commissioned to compose for the convention.

10
11 Chaplain Meyr concluded his devotion with a prayer. Among the petitions, he
12 prayed that just as the people in the *National Geographic* article had great zeal to save
13 the harbor seals so, too, we would have zeal in our ministry of fishing for the Lord.

14
15
16 **Registration and Credentials Committee**

17
18 The Reverend Robert Krueger, chairman of the Registration and Credentials
19 Committee, was called forward. He reported that as of 8:00 a.m. the number of
20 voting delegates present was as follows.

21
22 Pastors 163 out of a possible 188
23 Lay 194 out of a possible 222
24 Total 357 out of a possible 410

25
26 He announced a quorum was present, and on behalf of the committee he moved
27 adoption of the report. The motion was carried.

28
29
30 **Reading of the Convention Rules**

31
32 President Seitz directed the delegates to pages A-11 through A-12 in the
33 workbook. He introduced Mrs. Darleen Harens, the convention parliamentarian,
34 who read the proposed convention rules.

35
36 It was moved, seconded and carried to adopt the convention rules as read.

37
38
39 **Adoption of the Agenda**

40
41 President Seitz placed before the assembly the revised agenda for the convention
42 (pages A-18a through A-22a).

1 It was moved, seconded and carried to adopt the revised agenda.

2
3 President Seitz introduced the convention manager, Ms. Lu Clemmensen, and her
4 assistant, Ms. Julie Bigler.

5
6
7 **Devotional Bible Study Part I**

8
9 President Seitz introduced the Reverend Kenneth Klaus, Speaker of the Lutheran
10 Hour Radio Ministries of the International Lutheran Laymen's League. Rev. Klaus
11 based his presentation on John 21, which forms the basis of the convention theme,
12 "It's Time to Fish."

13
14
15 **Constitution and Membership Committee**

16
17 President Seitz introduced the Reverend Klemet Preus, chairman of the Constitution
18 and Membership Committee.

19
20 He explained the work of the committee. He reported that during the past
21 triennium the committee approved the constitutions and/or bylaws of fifty-one
22 congregations and two schools. Rev. Preus named and thanked the members of the
23 committee.

24
25
26 **Recognition of New Members**

27
28 President Seitz invited new ordained pastors and commissioned ministers to come
29 before the convention for recognition. (The new individual members are listed in
30 the Convention Workbook on pages E-1 through E-5 and E-14 through E-19.)

31
32 President Seitz announced that during the past triennium one new Minnesota South
33 District congregation was welcomed into the Synod - La Iglesia Luterana Cristo El
34 Redentor, St. Paul, MN. He introduced the lay delegate and invited him to come
35 forward as well.

36
37 President Seitz then introduced the Reverend Dr. Gerald Kieschnick, President of
38 the Lutheran Church-Missouri Synod, who addressed the new members and
39 offered them a word of welcome.

1 **President's Address**

2
3 President Seitz addressed the convention. He reviewed the past triennium and
4 shared his vision for mission outreach to the many new and existing ethnic
5 ministries found in the Minnesota South District. He stressed the urgency of our
6 work because life can change in an instant and the opportunity to hear the Gospel
7 and be saved can be quickly lost.

8

11 Ms. Lu Clemmensen introduced Mrs. Donna Seitz, wife of President Seitz, and
12 presented her with a bouquet of flowers to express appreciation for her support.

15 **Committee on Nominations**

16
17 President Seitz called forward the Reverend Dr. Larry J. Griffin, chairman of the
18 Committee on Nominations. Dr. Griffin introduced the members of the committee.
19 He presented the slate of candidates for the office of District President.

33 He explained how to use the Swank electronic response system and guided the
34 delegates in some test votes.

36 Chaplain Meyr was invited forward to offer a prayer before the voting for President
37 began. Rev. Markworth directed the delegates to cast their votes.

39 The Reverend Dr. Lane Seitz was declared elected on the second ballot.

1 **Synodical President's Report**

2
3 President Seitz again introduced Dr. Gerald Kieschnick, president of the Lutheran
4 Church—Missouri Synod (LCMS), who presented his official report to the
5 convention.

6
7 Dr. Kieschnick expressed his desire for the Missouri Synod to be ablaze with the
8 passion to seek the lost. He stressed that we in the Missouri Synod with our
9 commitment to the Word of God and our Confessions have great potential in
10 reaching the lost. He expressed confidence that in the United States and throughout
11 the world we are uniquely equipped to bring the Gospel to others.

12
13 He showed a video entitled "One Mission, One Message, One People," which
14 highlighted his vision for the LCMS.

15
16 Dr. Kieschnick concluded his presentation by responding to delegate questions
17 which had been submitted in writing. The questions were read by Ms. Lu
18 Clemmensen.

19
20
21 **Fishing Tip #1**

22
23 President Seitz introduced the first of a series of videos in which District
24 "fishermen" shared their experience and tips for how they reach out to unbelievers.
25 The first video emphasized the 24/7 aspect of sharing the Gospel.

26
27
28 **Closing Prayer**

29
30 Chaplain Meyr was invited forward. He offered a number of petitions on behalf of
31 individuals. Following a prayer of thanks for the meal, he led the convention in
32 rising and singing the doxology.

33
34 President Seitz declared the convention in recess until 1:00 p.m.

35
36
37 **Second Session**

38
39 **Opening Devotion**

40
41 President Seitz introduced the Reverend Fred Miller, co-chaplain for the convention.
42 Rev. Miller led the opening devotion. He stated that the one item essential for
43 fishing is the lure - the angle worm, minnow, spooner, the fly - each designed for

1 different kinds of fish and different fishing conditions. He noted that there are
2 literally hundreds of lures on the market. However, there are only two lures when
3 you fish for the souls of men—the Law and the Gospel.

4
5
6 **Resolutions A—B—C—D**

7
8 President Seitz directed the delegates to Resolution A (*Convention Workbook*, F—27).
9 Resolution A was adopted as printed (Y:301/N:45).

10
11 Resolution B (*CW*, F—28) was placed before the convention. A motion to remove
12 Memorial A—12 was defeated (Y:137/N:218). A motion to remove Memorial A—16
13 was defeated (Y:148/ N:205). Resolution B was adopted (Y:259/N:99) as printed.

14
15 Resolution C (*CW*, F—29 to F—30) was placed before the convention with Memorial
16 A—19 removed by action of the Doctrine and Administration Floor Committee. A
17 motion to remove Memorial A—4 was defeated (Y:121/N:213). Resolution C was
18 adopted (Y:289/N:74) as presented.

19
20 President Seitz explained that there were no items included in Resolution D, so no
21 action was needed by the convention.

22
23
24 **Doctrine and Administration Committee**

25
26 The Reverend Evan G. Schiller, chair of the Doctrine and Administration
27 Committee, was asked to come forward. He introduced the members of the
28 committee. Rev. Schiller presented Resolution 1—14, “To Realign Minnesota South
29 District Circuits in the 2003-2006 Triennium,” which had been distributed to the
30 delegates. (Note: As printed the title had “2005” rather than “2006”. The correction
31 was accepted by common consent.)

32
33 Rev. Bob Krueger was called forward. He reported a total of 383 voting delegates
34 (178 pastors, 205 lay) in attendance. It was moved, seconded and carried
35 (Y:321/N:20) to approve the updated credentials report.

36
37 Resolution 1—14 was adopted (Y:339/N:26) as presented.

38
39 Rev. Schiller read Resolution 1—02, “To Support the Continuation of Theological
40 Conferences” (*CW*, F—6). It was moved, seconded and carried (Y:273/N:92) to
41 amend the resolution to add two additional resolves:

1 *RESOLVED*, that such forums be designed to identify the theological issues
2 and practices over which there is disagreement, and be it finally

3
4 *RESOLVED*, that the differences be resolved in accordance with Scriptures
5 and the Lutheran Confessions so that we may “with one heart and mouth
6 glorify the God and Father of our Lord Jesus Christ.” (Romans 15:6)

7
8 Resolution 1 – 02 was adopted (Y:337/N:29) as amended.

9
10 Rev. Schiller presented Resolution 1 – 03, “To Encourage Uniformity in Church
11 Practice and Appreciation of Responsible Practices and Customs” (CW, F – 7 to F –
12 8). In the reading of the first resolve Rev. Schiller noted a correction on line 35,
13 changing “is” to “are.” As it was read the committee also removed the words “in all
14 areas of his work and communication in District” in the final resolved clause.

15
16 A motion was moved, seconded and defeated (Y:133/N:223) to remove lines 5
17 through 7 on page F – 8.

18
19 President Seitz called for the orders of the day. The committee was dismissed before
20 a final vote on Resolution 1 – 03 could be taken.

21
22
23 **Fishing Tip #2**

24
25 President Seitz introduced the kindergarten class from St. John Lutheran Church
26 and School in Chaska, MN. They sang a song “Goin’ Fishin’,” which reflected the
27 convention’s theme.

28
29 President Seitz introduced the second fishing tip video. This segment focused on
30 the issue of witnessing as a congregation.

31

33 **Elections and Nominations Committees**

34
35 Rev. James Markworth was invited forward. He announced that balloting would
36 now be held for the ranking of the vice presidents. The result of the voting is as

6
7 President Seitz introduced the next video fishing tip. This segment stressed the
8 importance of knowing the lake we fish, that is, knowing the community where we
9 live and serve.

12 **Mission Committee**

13
14 President Seitz introduced the Reverend Robert Gardner, chairman of the Missions
15 Floor Committee. Rev. Gardner introduced the members of the committee. He read
16 Resolution 2-01, "To Be a Church in Mission" (CW, F-19). The resolution was
17 adopted (Y:278/N:15) as presented.

18
19 In response to the passage of this resolution, Chaplain Meyr offered a prayer.

20
21 Rev. Gardner presented Resolution 2-02, "To Celebrate the Mission Work of the
22 District" (CW, F-20). The resolution was adopted (Y:295/N:10) as presented.

23
24 Rev. Gardner presented Resolution 2-03, "To Support Missions in Minnesota
25 South" (CW, F-20A). The resolution was adopted (Y:274/N:45) as presented.

26
27 Rev. Gardner reported that the work of the committee was completed. President
28 Seitz dismissed the committee with the convention's thanks.

31 **Fishing Tip #4**

32
33 President Seitz introduced the next video fishing tip. The theme of this segment was
34 "Find the Best Bait," which focused on meeting the needs of the community.

37 **Lutheran Women's Missionary League**

38
39 President Seitz introduced Mrs. Gloria Kenow, the new president of the Minnesota
40 South District of the LWML, who addressed the convention via video tape.

1 Commemoration Update

2
3 President Seitz announced that in the commemorations during the opening worship
4 the name of the Reverend Dr. Gerhard Michael was inadvertently omitted. He
5 explained that a certificate had been prepared, and it will be sent to the Michael
6 family along with an apology for the oversight.

7
8
9 Devotional Bible Study

10
11 President Seitz again welcomed Rev. Ken Klaus to present the second part of his
12 devotional Bible study. He returned to John 21. He noted that Peter is a man of
13 action. As soon as he hears John shout "It is the Lord," Peter doesn't hesitate but
14 jumps into the water and swims to shore.

15
16 Rev. Klaus reminded the delegates that the duty of a faithful missionary, which is all
17 of us, is to concentrate on the Lord Jesus Christ. God gives ordinary people an
18 extraordinary message and tells us to let down the nets. The fishing should not be
19 left to professional ministers but all of us should be involved in the work.

1 **Special Presentation - "It's time to Fish."**

2
3 President Seitz introduced the Reverend Stephen Wipperman, Assistant to the
4 President for Missions. Rev. Wipperman led the missionaries of the District in a
5 dramatic cantata written by Dr. Jeffrey Burkart.

6
7 President Seitz stated that we need to be concerned to share the Gospel of hope with
8 those who are hurting and in need. He explained that mission work is expensive
9 and that funds from the recent "Fear Not, Go Forward" fund drive will soon be
10 depleted. He stated that we need to rely on the generosity of our people and raise
11 money for missions.

12
13 President Seitz introduced the Reverend Peter Meier, chairman of the District
14 Missions Committee. Rev. Meier explained that the goal of the "It's Time to Fish"
15 campaign is to have 1,000 partners contribute \$1,000 per year for three years. The
16 goal is to raise a million dollars for each of three years for missions. He asked the
17 delegates to join this mission emphasis.

18
19 Rev. Wipperman asked people to fill out the cards and bring them forward and
20 place the pledges in the box by the stage. He led those present in singing selected
21 verses from "Our Mission is Fishin'!" He concluded the special presentation with a
22 prayer.

23
24 President Seitz led the assembly in singing Happy Birthday to Pastor Richard Miller,
25 Pastor Klemet Preus, and Jonathan Vollrath.

26
27
28 **Greetings from the Minnesota North District President**

29
30 Dr. Seitz introduced Rev. Donald Fondow, newly elected president of the Minnesota
31 North District.

32
33 Rev. Fondow noted how the themes for the two conventions worked well together
34 "Till the Trumpets Sound It's Time to Fish." He greeted the assembly and offered a
35 word of hope. At one time the LCMS considered retrenchment, but chose not to do
36 that. We cannot advance the church by retrenchment. The Easter message propels
37 us forward, in spite of limited resources.

38
39
40 **Finance Committee**

41
42 President Seitz called the Finance Committee forward. The chairman, Dr. James
43 Heining, introduced the rest of the committee members. He acknowledged and

1 commended the fine work of Lu Clemmensen and Julie Bigler. He pointed out the
2 high praise that the auditors gave to their work.

3
4 Dr. Heining introduced Resolution 5-02, "To Accept the Report of the Finance
5 Committee" (CW, F-26). Resolution 5-01 was adopted as presented (Y:300/N:9).

6
7 Dr. Heining then introduced Resolution 5-01, "To Memorialize Synod to Increase
8 Financial Support for Our Synodical Seminaries" (CW, F-25). Resolution 5-01 was
9 adopted as presented (Y:297/N:22)

10
11 Dr. Heining reported that the committee's work was completed. President Seitz led
12 the assembly in dismissing the committee with its thanks.

13
14
15 **Closing Prayer**

16
17 Chaplain Meyr was invited forward to offer a prayer to conclude this session and to
18 bless the meal. He led the assembly in singing two verses of "Hark, the Voice of
19 Jesus Calling."

20
21 The convention stood in recess until 6:45 p.m.

22
23
24 **Third Session**

25
26 **Opening Prayer**

27
28 President Seitz called the convention to order. Chaplain Victor Meyr led the
29 opening devotion for the evening session. Following his prayer a choir, composed
30 of convention attendees, sang the Navy Hymn.

31
32
33 **Fishing Tip #5**

34
35 President Seitz introduced the next segment in the video series on fishing tips,
36 which provided examples of intentional efforts to make visitors welcome.

37
38
39 **Elections and Nominations Committees**

40
41 Dr. Griffin, chair of the Nominations Committee, was invited forward. He
42 explained that according to a ruling by Synod's Commission on Constitutional
43 Matters emeritus pastors are not considered parish pastors, thus Rev. Palmer

1 Ruschke as an emeritus pastor is not eligible to serve on the District Nominations
2 Committee.

3
4 Dr. Griffin stated that the bylaws are unclear with regard to the eligibility of Dr.
5 James Pragman. He explained that two options are available to the convention.
6 First, the convention could remove Dr. Pragman's name from the ballot or, second,
7 the convention could allow his name to stand and if he is elected a CCM opinion
8 would be requested to clarify the term parish pastor and rule on Dr. Pragman's
9 eligibility.

10
11 Rev. James Markworth, chair of the elections committee, was invited forward. He
12 presented the amended slate for the parish pastor positions on the District
13 Nominations Committee. He explained that because the convention is to elect four
14 people, the screen will appear four times and each delegate is to cast a different vote
15 on each screen.

16
17 The vote was taken and the results shown. A point of order was raised. It was
18 noted that the numbering of two candidates on the results screen was not the same
19 as the numbering presented on the voting screen. The Swank technician reported
20 that there was a glitch in the system. President Seitz ordered that the vote be
21 retaken in order to maintain the credibility of the vote.

22
23 In order to allow time for Swank to correct the problem, President Seitz ordered that
24 the convention proceed with the agenda and return to the elections at the earliest
25 opportunity.

26
27
28 **Fishing Tip #6**

29
30 President Seitz introduced the next video fishing tip, which focused on intentional
31 invitation as a means to cast the net.

32
33
34 **Presentation of the "Volunteer Teacher of the Year" Award**

35
36 President Seitz invited Signe Carlson of Lutheran Education Volunteer Network
37 (LEVN) to come forward and present the "Minnesota South District 2003 Volunteer
38 Teacher of the Year Award." It was presented to Curtis Boger of Holy Cross
39 Lutheran Church in Rochester, MN.

1 District Archivist
2

3 President Seitz introduced the Reverend Dr. Glen Offermann, Minnesota South
4 District Archivist and author of Missouri in Minnesota. In a videotaped address Dr.
5 Glenn Offermann explained the work of the archivist in preserving the history of the
6 District and the LCMS.
7
8

9 Congregational Services Committee
10

11 President Seitz introduced the Reverend Robert Gehrke, who in turn introduced the
12 members of the Congregational Services Committee.
13

14 Rev. Gehrke presented Resolution 3-01, "To Make Recruitment for and Retention
15 of Church Vocations a Concern of the Entire Church" (CW, F-21 to F-22), which
16 was adopted as printed (Y:279/N:15).
17

18 Resolution 3-02, "To Recognize Missouri Synod Church Musicians" (CW, F-23),
19 was presented. By common consent the resolution was corrected by deleting the
20 words "recommend to the District Convention to" from the final resolve. Resolution
21 3-02 was adopted as corrected Y:260/N:35)
22

23 Resolution 3-03 "To Accept the Reports of the Congregational Services
24 Subcommittee, Schools/Commissioned Ministers Committee and the Ministerial
25 Health Committee" (CW, F-24), was laid before the convention. It was adopted as
26 printed (Y:284/N:11).
27

28 Rev. Gehrke reported that the work of the committee was completed, and President
29 Seitz led the assembly in dismissing the committee with its thanks.
30

31 President Seitz shared his thoughts and concerns regarding the issue of recruitment
32 and retention addressed in Resolution 3-01. He stated that we are facing a critical
33 shortage of pastors, that by the year 2017, even taking into consideration those who
34 graduate from our seminaries, the number of pastors in the LCMS will be 2,200. He
35 stressed the tremendous need to prepare people for service in the Church.
36
37

38 Fishing Tip #7
39

40 President Seitz directed the delegates attention to the next fishing tip video, which
41 focused on ways to invite people intentionally by casting the net on "the other side."
42
43

1 Greetings from former MNS President - Rev. Dr. Martin Lieske

2
3 President Seitz introduced Rev. Dr. Martin Lieske, past president of the Minnesota
4 South District. He greeted the delegates and reminded them that as Christians they
5 are the aroma of Christ to the sinful world. He urged the delegates to be about
6 God's work, sharing Christ by witness and by our life. He observed that our church
7 body is rapidly graying, and in many churches older members outnumber the
8 younger. He commended the older adult ministry group SAGES (Saints Alive
9 Growing Ever Serving) as a helpful organization for keeping older adults active in
10 service to the Lord.

11
12
13 Elections and Nominations Committees

14
15 Rev. James Markworth, chair of the Elections Committee, was invited forward. A
16 point of order was raised regarding the eligibility of Dr. James Pragman to serve on
17 the District Nominations Committee. President Seitz put to the convention the
18 question whether or not Dr. Pragman qualifies as a parish pastor and can remain on
19 the ballot. He explained that a yes vote would allow Dr. Pragman's name to remain
20 on the ballot; a no vote would remove his name.

21
22 The vote was 148 yes, 150 no. The name of Dr. James Pragman was removed from
23 the ballot.

24
25 The ballot was amended, and Rev. Markworth directed the delegates to vote.
26 During one of the voting segments someone called out, and Rev. Markworth called
27 for a halt in the timer. This resulted in President Seitz declaring the vote invalid and
28 calling for the voting to be redone. He urged the delegates to refrain from anything
29 that would disrupt the voting while the timer is running.

30
31 The ballot was reset and shown on the screen. Over the course of three ballots the
32 following were elected.

33
34 Rev. Roger Abernathy (1st ballot)
35 Rev. Jack Baumgarn (1st ballot)
36 Rev. Dr. Eugene Chase (1st ballot)
37 Rev. Thomas Braun (3rd ballot)

38
39 A point of order was raised if being elected to the District Nomination Committee
40 violated the provision against holding more than one elected office. President Seitz
41 referred to District Bylaw 2.40h: the Committee on Convention Nominations is an
42 *ad hoc* committee to which the restriction of holding more than one office does not
43 apply.

1
2 Rev. Markworth asked that the ballot for the lay members of Nominations
3 Committee be displayed on the screen. Over the course of three ballots the
4 following lay people were elected.

5
6 Mr. Glen Meints (1st ballot)
7 Mr. Christian Preus (1st ballot)
8 Mr. Armin Tesch (1st ballot)
9 Ms. Doris Heidorn (3rd ballot)

10
11 Rev. Markworth asked that the ballot for the teacher member of Nominations
12 Committee be displayed on the screen.

13
14 Mr. Lloyd Luehmann was declared elected on the first ballot.

15
16 A point of order was raised whether or not the person elected to the Synodical
17 Nominations Committee was exempt from the provision of holding multiple offices.
18 President Seitz referred to Synodical Bylaw 3.980g; the Nominations Committee is
19 an *ad hoc* convention committee to which the restriction of holding more than one
20 office does not apply.

21
22 Rev. Markworth called up the ballot for the 2004 Synodical Nominations Committee.

23
24 The Reverend Donald Taylor was declared elected on the second ballot.

25
26 Rev. Markworth then placed the names of Rev. Jack Baumgarn and Rev. Klemet
27 Preus before the convention as the slate for alternate to 2004 Synodical Nominations
28 Committee.

29
30 The Reverend Jack Baumgarn was declared elected.

31
32 Rev. Markworth reported that the work of the committee was completed. President
33 Seitz led the assembly in dismissing the committee with its thanks. He also asked
34 for a round of applause for the people running the Swank system for their work in
35 making the convention run smoother.

36
37
38 **Fishing Tip #8**

39
40 President Seitz introduced the next fishing tip video segment, which focused on
41 music as a means to reach people.

1 Closing Devotion

2
3 Convention Chaplain, Rev. Victor Meyr, was invited forward. He offered a closing
4 prayer, in which he offered up petitions on behalf of various people. He concluded
5 by leading the delegates in singing "Go, My Children, with My Blessing."
6

7 The convention stood in recess until 8:00 a.m. Saturday morning.
8
9

10 **Saturday, June 14, 2003**

11
12 Fourth Session

13
14 Opening Devotion

15
16 President Seitz called the convention to order at 8:00 a.m.
17

18 Chaplain Victor Meyr was called forward to lead the opening devotion. In honor of
19 Flag Day, he led the assembly in reciting the pledge of allegiance. Rev. Meyr
20 expressed his pleasure with Resolution 2-01, especially in light of the words which
21 urge us to confess our sins and to receive absolution "in order to set us free to
22 worship." It feels good when people say, "I forgive you, and I won't hold it against
23 you." He encouraged the delegates not to wait for others to come to them, but
24 quickly go to others. We should seek the forgiveness because it sets us free. He
25 invited the assembly to rise and sing "Our Mission is Fishin'." Rev. Meyr then
26 concluded with a prayer.
27

28
29 International Lutheran's Layman's League

30
31 President Seitz introduced Mr. Charles Groth, president of the Minnesota South
32 District of the LLL, who addressed the convention via video tape. He presented a
33 brief summary of the work of the LLL.
34

35
36 Devotional Bible Study - Part III

37
38 Rev. Kenneth Klaus, Speaker for Lutheran Hour Ministries, continued his Bible
39 study on John 21. He told the delegates that they cannot decide whether or not they
40 will witness. He said, "You will witness. You will either witness verbally with your
41 mouth and visibly with your actions that Jesus is your Lord and Savior, or you will
42 witness, through inactivity, that Christ is "no big deal in your life." The issue,
43 according to Rev. Klaus, is one of priority. He reminded the delegates that they

1 have been called to be fishers of men, and that they are trusting the Lord when they
2 let down the nets.

3
4 President Seitz led the assembly in thanking Rev. Klaus for his devotional Bible
5 study.

6
7
8 Doctrine and Administration Committee

9
10 Rev. Evan Schiller, chairman of the Doctrine and Administration Committee, was
11 invited forward. He explained that due to the orders of the day debate on
12 Resolution 1-03 (CW, F-7 to F-8) was suspended until this time. He placed the
13 resolution again before the convention.

14
15 *(Secretary's note: A motion to amend the resolution had been defeated, and at this time the*
16 *convention considered the original resolution.)*

17
18 It was moved and seconded to amend the second to last resolved clause (CW, F-8,
19 lines 5-7) to read as follows:

20
21 **RESOLVED**, That our congregations remember that while many worship
22 resources **may be** available which **may be** doctrinally pure but may not yet
23 have official synodical approval, **they may not be appropriate for regular**
24 **congregational use**; and be it finally

25
26 The amendment was defeated (Y:130/N:169).

27
28 It was moved and seconded to amend the third whereas clause (CW, F-7, line 29) to
29 change the citation from "Article XXVI, 40-42" to "Article XXVI, 40-45." Additional
30 paragraphs of the citation were read to the delegates. The amendment was adopted
31 (Y:182/N:115).

32
33 A motion made and seconded to end debate was adopted (Y:216/N:80).

34
35 Resolution 1-03 as amended was adopted (Y:167/N:133)

36
37 Rev. Schiller placed before the convention Resolution 1-06, "To Clarify
38 Relationships with the Evangelical Lutheran Church in America" (CW, F-11). The
39 first whereas clause was amended by common consent to replace the words "no
40 longer is" with "is not."

41
42 President Seitz called for the orders of the day, and debate on Resolution 1-06 was
43 suspended until the next time the committee was scheduled.

1 **Special Presentations**

2
3 President Seitz invited the outgoing members of the District Board to come forward.
4 They are Rev. James Heining, Mrs. Carol Olson, Mr. Raymond Mussell Jr., Mr.
5 Delbert Schwieger, Mr. Curt Stoltenow, Rev. Randolph Sherren, Mrs. Connie
6 Marquart, and Rev. Dr. Benjamin Buck.

7
8 He offered his personal thanks to them for their service to the District. He presented
9 plaques to Mr. Prigge and Mr. Stoltenow and shepherd staffs to Rev. Sherren and
10 Rev. Buck.

11
12
13 **Fishing Tip #9**

14
15 President Seitz introduced the next video fishing tip, which focused on the
16 importance of reaching out to and involving youth in the church.

17
18
19 **Doctrine and Administration Committee**

20
21 Rev. Evan Schiller was again called forward. Debate on Resolution 1-06 (as
22 amended) was resumed. A motion to substitute Memorial A-11 was defeated
23 (Y:133/N:157). Resolution 1-06 as amended was adopted (Y:248/N:48).

24
25 Resolution 1-04, "To Provide for a More Accurate Representation of Lay People to
26 District and Synodical Conventions" (CW, F-9), was placed before the convention.
27 Resolution 1-04 was defeated (Y:59/N:245).

28
29 Resolution 1-10, "To Request the Synod to Elect Members of the Commission on
30 Constitutional Matters" (CW, F-15), was read. The resolution was adopted as
31 printed (Y:217/N:88).

32
33 Resolution 1-08, "To Refer the Issue of Worship Resources Used on the Campus of
34 Concordia University, St. Paul" (CW, F-13), was presented. A motion to substitute
35 Memorial A-21 was defeated (Y:135/N:166). Resolution 1-08 was adopted as
36 printed (Y:220/N:83)

37
38 Resolution 1-01A, "To Resolve Technical Issues Relating to the Nominations and
39 Elections Process and Other Handbook Issues" (CW, F-1 to F-5), was presented.
40 [Note: This resolution is identical to Floor Committee Res. 1-01, except that the
41 second "Resolved" clause in that version was deleted by the Floor Committee when
42 it presented the resolution to the convention.]

43

1 It was moved, seconded and carried to dispense with the reading of Resolution 1--
2 01A. The resolution was adopted (Y:272/N:21).

3
4
5 Fishing Tip #10

6
7 President Seitz invited the assembly to consider another video fishing tip, which
8 dealt with reaching out to and involving the family.

9
10
11 Doctrine and Administration Committee

12
13 The Doctrine and Administration Committee was invited forward. Rev. Evan
14 Schiller presented Resolution 1-15, "To Review Opinion 02-2309 of the
15 Commission on Constitutional Matters," was read. A printed copy was distributed
16 to the delegates.

17
18 A lively debate ensued. It was moved, seconded and carried to end debate
19 (Y:271/N:23). Resolution 1-15 was adopted as printed (Y:154/N:142).

20
21 Resolution 1-05, "To Review the Action of Concordia University, St. Paul, in
22 Relation to the Elimination of Tenure and Tenure Track Faculty Positions" (CW, F-
23 10), was presented. Rev. Schiller read a letter from Rev. William Meyer, Executive
24 Director of Synod's Board for Higher Education, to Concordia, St. Paul, in which he
25 explained that the Board was satisfied that the University Regents has handled the
26 matter correctly.

27
28 Resolution 1-05 was defeated (Y:109/N:184).

29
30 Resolution 1-07, "To Clarify the Opportunity for Women to Serve as Executive
31 Director or President and Assistant Director or Vice President" (CW, F-12), was
32 presented.

33
34 It was moved and seconded to amend the resolved to read as follows.

35
36 *RESOLVED*, The Minnesota South District in Convention request the CTCR
37 to make a recommendation to the Synod as **early as possible** on this issue.

38
39 The amendment was adopted (Y:223/N:73). Then Resolution 1-07 was adopted
40 (Y:233/N:60) as amended.

41
42 Resolution 1-11, "To Voice Support for Our Synodical Leaders" (CW, F-16), was
43 read. The resolution as printed was adopted (Y:225/N:67).

1
2 Resolution 1–12, “To Refer Nicene Creed Wording Changes to Synod’s
3 Commission on Worship” (CW, F–17), was presented. The resolution as printed
4 was adopted (Y:204/N:91).

5
6 Rev. Evan Schiller presented Resolution 1–09, “To Address the Actions of
7 International Lutheran Layman’s League as LCMS Auxiliary” (CW, F–14). After
8 some debate, it was moved, seconded and carried to end debate (Y:270/N:23).
9 Resolution 1–09 was adopted (Y:206/N:23).

10
11 Resolution 1–13, “To Accept Reports of the Board of Directors, Communications
12 Committee and 2003 Theological Conference” (CW, F–18), was read. The
13 resolution was adopted (Y:280/N:5)

14
15 Rev. Evan Schiller reported that the committee had concluded its business.
16 President Seitz led the assembly in dismissing the committee with thanks.

17
18
19 **Fishing Tip #11**

20
21 President Seitz introduced the final fishing tip video, which reminded the delegates
22 to be faithful witnesses.

24 as youth delegate.

25
26 President Seitz invited Dr. James Pragman forward. He introduced the youth
27 delegates who have been attending the convention: Mr. Tyler Evans, Mr. Michael
28 Evans, and Ms. Amy Sandhurst.

29
30 The convention ratified the selection of Tyler Evans as Youth Delegate by a vote of
31 242 to one.

36 President Seitz directed the delegates to pages A-49 and A-50 in the Convention
37 Workbook, which acknowledged those who had made the convention
38 arrangements. He led the convention in expressing thanks for their work.
